CONSIDERING that the participant knows his/her own abilities and limitations regarding the events to which he/she is registered, with regard to admission to participate in these scheduled events, the participant expressly and voluntarily agrees to the following:

1. ASSUME ALL RISKS of personal injury and/or death arising from participation in and/or training for the various events;
2. to inspect the site [course] before training for or participating in any event;
3. WAIVE ANY CLAIMS the participant may have in the future against SK ASKÖ Landskron Snowboard, its officers, officers, assistants, members, representatives, employees, directors, affiliated companies, subsidiaries and any insurance companies for any losses , damage, injury or financial expense suffered by the participant, or suffered by the participant's relatives, which is a result of the participant's training for or his/her participation in any scheduled event, due to any cause including but not limited to negligence on the part of SK ASKÖ Landskron Snowboard, its officers, officers, assistants, members, agents, employees, directors, sister companies, sponsors, subsidiaries and any organization or person responsible for carrying out any function in connection with Sparkasse Freestyle State Cup Carinthian Masters– NASH Tour Stop – Big Air, as well as on the part of all volunteers;
